Job Description

- Monitor and process the quarterly held Royalties Distribution, make sure the

 with the music data collected.
- Deliver complete and accurate performance inputs to CASH's quarterly distribution by managing music usage reports, cue sheets and performance identification processes.
- Work closely with the Team Head to plan strategies for streamlining the workflow

Responsibilities

- Communicate with external parties for music usage reports /cue sheets and maintaining regular follow-ups to ensure timely receipt of information
- Gather data from various sources and transfer the data into insightful information to accelerate the royalty distribution cycle
